She was coordinator of the Voices for Justice (the Archdiocesan legislative network) and other advocacy functions for the Archdiocese. This collection contains many files related to Consistent Life Ethic pamphlets, Rural Life Conference, Pentecost Together Ecumenical movement, Voices for Justice, and other human concerns and social justice related programs.
